

OSHA Citations and Penalties Bulletin - No. 48

The Occupational Safety and Health Administration (OSHA) is authorized to issue citations and penalties against an employer when workplace health and safety standards have been violated. Citations are classified as *De Minimus, Other-Than-Serious, Serious, Willful, Repeat, or Failure to Abate*. Penalties are proposed based on a variety of factors including site conditions, size reduction, good faith, minimum penalties, and history. The information below is not an official OSHA document, but is a summary of alleged violations and penalties collected from notices, safety orders, press releases, etc. issued directly by OSHA.

Knowing the current citation and penalty trends helps an employer better evaluate their current performance, understand conditions that OSHA considers to be hazardous and to recognize the penalty values that might be assessed.

Violation:	The employer did not ensure that each affected employee uses appropriate eye or face protection when exposed to eye or face hazards from flying particles, molten metal, liquid chemicals, acids or caustic liquids, chemical gases or vapors, or potentially injurious light radiation.			
Site Specific Violation:	Facility – Employees working at the dip tanks were exposed to chemical burns from hazardous chemicals such as, but not limited to, sodium hydroxide while not wearing appropriate eye or face protection to protect from the hazardous chemicals.

Shop floor, 18" chop saw – Employees were exposed to ingoing nip points when there was an inclined belt and pulley transmitting power to the 18" chop saw that was not fully enclosed during operation.

Violation:	The employer did not establish and maintain conditions of work which were reasonably safer and healthful for employees, and free from recognized hazards that were causing or likely to cause death or serious physical harm to employees from injuries such as blunt force and penetrating trauma.			
Site Specific Violation:	Gas Station - The employer did not develop and implement a workplace violence prevention program. Employees were exposed to hazards such as, but not limited to, robberies with weapons, threats of violence, and assaults. From February 2015 to February 2020 the Police Department had been dispatched to this location over 250 times. On February 27, 2020 at approximately 10:30 pm and employee was fatally shot.
